Resolution dedicating certain City-owned land for public alley purposes to widen the west leg of the east-west alley in the block bounded by West Cherry Street, West Vliet Street, North 33rd Street and North 34th Street, in the 4th Aldermanic District of the City of Milwaukee. This resolution will dedicate City-owned land for public alley purposes to widen the west leg of the east-west alley in the block bounded by West Cherry Street, West Vliet Street, North 33rd Street and North 34th Street. Whereas, The City of Milwaukee has Fee Title to a certain parcel of land located at 1418 through 1420 North 34th Street; and

Whereas, Widening this alley leg from 14 feet to 20 feet will improve vehicular circulation for the abutting property owners as well as for garbage trucks; and

Whereas, The widening and improvement of the alley, adjacent to said land, is scheduled on the 2003 alley paving program; now, therefore, be

Resolved, By the Common Council of the City of Milwaukee that the following described City-owned land hereby is set aside and dedicated for public alley purposes:

That part of Lot 18 in Block 16 of Walnut Hill, a recorded subdivision, in the Southeast ¼ of Section 24,

Township 7 North, Range 21 East, described as follows: Commencing at the southwest corner of Lot 18; thence Northerly, along the west line of Lot 18, to a point lying 6.00 feet north of, as measured normal to, the south line of Lot 18; thence East, parallel to said south line, to a point lying 10.00 feet west of, as measured normal to, the east line of Lot 18; thence Northeast to a point in said east line, said point lying 16.00 feet north of, as measured normal to, said south line; thence Southerly, along said east line, to the southeast corner of Lot 18; thence Westerly, along said south line, 120.00 feet to the point of commencement; and, be it

Further Resolved, That the City Comptroller is hereby directed to have a certified copy of this resolution recorded in the office of the Register of Deeds of Milwaukee County.
