THE CHAIR

A substitute ordinance relating to parking controls in various Aldermanic Districts. This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On the east side of North 48th Street from the south curb line of West North Avenue to a point 190 feet south thereof at any time"

"On the west side of North Holton Street from the north line of East Reservoir Avenue to a point approximately 90 feet north thereof"

"On North 30th Street from West Atkinson Avenue to West Ruby Avenue"

"On the east side of North 18th Street from the north curb line of West Keefe Avenue to a point 60 feet north thereof at any time"

"On the east side of North 12th Street from West Burleigh Street to West Capitol Drive from 3:30 PM to 5:30 PM except Saturday and Sunday and where No Parking is in effect"

"4134 West Villard Avenue from the driveway to a point 30 feet east at any time"

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the west side of South 34th Street from West National Avenue to a point 35 feet south at any time

Part 3. Section 101-23-4-b of the Code relating to One-Half Hour Parking is amended by striking the following:

"On the east side of North 37th Street from the north curb line of West Courtland Avenue to a point 80 feet north thereof"

Part 4. Section 101-23-4-d of the Code relating to Two Hour Parking is amended by striking the following:

"On the east side of North 27th Street from the south curb line of West Hope Avenue to a point 270 feet south thereof from 7:00 AM to 7:00 PM"

"On North 26th Street from West Auer Avenue to West Burleigh Street except Saturday, Sunday and Holidays"

"On the south side of West Silver Spring Drive from North Teutonia Avenue east to the driveway of the Gaylord Container Corporation"

"On West Pierce Street from South 35th Street to South 39th Street"

"On the north side of West Pierce Street from South 35th Street to South 37th Street"

Part 5. Section 101-23-4-d of the Code relating to Two Hour Parking is amended by adding the following:

On the north side of West Pierce Street from South 36th Street to South 37th Street

Part 6. Section 101-23-10-a of the Code relating to Winter Parking Restrictions is amended by striking the following:

"On the north side of East Estes Street from South Kinnickinnic Avenue to South Shore Drive"

Part 7. Section 101-26.5-1-a of the Code relating to No Parking When Snowfall Two Inches Or More is amended by striking the following:

"On the east side of North Bremen Street from East Locust Street to East Chambers Street"

Part 8. Section 101-26.5-1-a of the Code relating to No Parking When Snowfall Two Inches Or More is amended by adding the following:

On the east side of North Bremen Street from East North Avenue to East Burleigh Street

On the west side of North Fratney Street from East Meinecke Avenue to East Locust Street

On the east side of North Pierce Street from East Meinecke Avenue to East Burleigh Street

On the north side of East Ivanhoe Place from North Farwell Avenue to North Prospect Avenue

Part 9. Section 101-27-3-b-1 of the Code relating to Alternate Side Night Parking Exceptions is amended by adding the following:

On South 22nd Street from West Scott Street to West Greenfield Avenue

On South Wentworth Avenue from East Conway Street to East Russell Avenue
