Resolution amending Common Council File 030668 relative to application, acceptance and funding of the Early Child Care Grant. (Health Department)

This resolution amends Common Council File 030668 relative to application, acceptance and funding of the Early Child Care Grant. The purpose of the grant is to assure the health and safety of children, birth to five years of age, who attend group-licensed childcare centers.

Whereas, Common Council File 030668 authorized the Health Department to apply for, accept and fund the Early Child Care Grant from the U.S. Department of Health and Family Services, Health Resources and Services Administration for the purpose of assuring the health and safety of children, birth to five years of age,

who attend group licensed childcare centers. This grant provided for a Grantor share total of \$496,750; and

Whereas, The Grantor share for this program is increased by \$270,610; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the U.S. Department of Health and Family Services, Health Resources and Services Administration is authorized and the Health Department shall accept such a grant without further Common Council approval unless the terms of the grant change as indicated in Common Council File 030712 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to commit funds within Project/Grant Parent of the 2004 Special Revenue - Grant and Aid Projects Fund, the following amount for the project titled Early Child Care Grant:
