Substitute Resolution relative to application, acceptance and funding of a Campaign Safe & Sober Grant.

This substitute resolution authorizes the Police Department to apply for, accept and fund a Campaign Safe & Sober Grant from the Wisconsin Department of Transportation Bureau of Transportation Safety in the amount of \$12,650 with a city share of \$9,650 and a grantor share of \$3,000. The purpose of the project is to highlight safety belt, child safety seats and speed laws in coordination with others in the State during December, February and July.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the National Highway Traffic Safety Administration through the Wisconsin Department of Transportation, Bureau of Transportation Safety for a Safe & Sober Campaign Grant; and

Whereas, The operation of this grant project from October 1998 to September 1999 would cost \$12,650 of which \$9,650(76%) would be provided by the city and \$3,000(24%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Transportation is authorized and the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Encumber in the parent accounts of the 1998 Special Revenue Accounts-Grant and Aid Projects, the following amounts for the project titled: Campaign Safe & Sober Grant
