and basic life support-emergency ambulance conveyances. The increases are as follows:

1. For residents, a 2.7% increase from \$598 to \$614.

2. For non-residents, a 2.7% increase from \$692 to \$711. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 75-15-14-c-1 and 2 of the code is amended to read:

75-15. Ambulance Certification Regulations.

14. DETERMINING RATES BILLED BY PRIVATE SECTOR PROVIDERS.

c-1. For patients who are residents of the city of Milwaukee, for basic life support, [[598]] >>614 <<and, for basic life support-emergency, [[598]] >>614<<. When patients require treatment without transport, a [[142]] >>146<< basic life support non-transport fee applies.

c-2. For patients who are not residents of the city of Milwaukee, for basic life support, [[\$692]] >><u>\$711</u> << and, for basic life support-emergency, [[\$692]]>><u>\$711</u><<. When patients require treatment without transport, a [[\$203]]>><u>\$208</u><< basic life support non-transport fee applies. APPROVED AS TO FORM
