An ordinance relating to ambulance conveyance rates and ancillary charges.

75-15-14-c-2 am

This ordinance increases the amounts charged to residents and non-residents for basic life support and basic life support-emergency ambulance conveyances. The increases are as follows:

1. For residents, a 2.7% increase from \$598 to \$614.

2. For non-residents, a 2.7% increase from \$692 to \$711.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 75-15-14-c-1 and 2 of the code is amended to read:

75-15. Ambulance Certification Regulations.

14. DETERMINING RATES BILLED BY PRIVATE SECTOR PROVIDERS.

c-1. For patients who are residents of the city of Milwaukee, for basic life support, ~~[[\\$598]]~~ >>\$614 <<and, for basic life support-emergency, ~~[[\\$598]]~~ >>\$614<<. When patients require treatment without transport, a ~~[[\\$142]]~~ >>\$146<< basic life support non-transport fee applies.

c-2. For patients who are not residents of the city of Milwaukee, for basic life support, ~~[[\\$692]]~~ >>\$711 << and, for basic life support-emergency, ~~[[\\$692]]~~ >>\$711<<. When patients require treatment without transport, a ~~[[\\$203]]~~ >>\$208<< basic life support non-transport fee applies.
