Resolution relating to expenditure of funds to be reimbursed by greater than anticipated revenue (Milwaukee Police Department).

This resolution authorizes the Office of the Comptroller to increase appropriations in the Special Purpose account for Contributions allowing for execution of the transfer authorized in Resolution 040783.

Whereas, Common Council File Number 980965 established procedural guidelines related to the expenditure of funds to be reimbursed by greater than anticipated revenues; and

Whereas, Section 304-24 of the City of Milwaukee Code of Ordinances regulates the receipt, appropriation and expenditure of contributions received by the City; and

Whereas, The Estimated Contribution Revenue account as a source of funds for general city purposes was established at \$950,000 as a result of the 2004 Budget process; and

Whereas, Contribution revenue received to date exceeds \$761,558; and

Whereas, Resolution File Number 040783 authorizes the transfer of funds from the Police Department's Federal Forfeiture Trust Fund to the Federal Forfeiture Contribution Revenue account and their subsequent expenditure; and

Whereas, There is insufficient appropriations to accomplish this transfer in accordance with the established procedural guidelines; and	
Whereas, The Comptroller has certified greater than anticipated revenue in the amount of \$845,000; and	
Pursuant to s. 304-91, I hereby certify that the money required for this item is anticipated to be realized on or before 12/31/2004 to be expended only for the purpose in this resolution.
