Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$7,816,000 for a total estimated cost of these projects being \$9,181,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$7,816,000. The total estimated cost of these projects is \$9,181,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Birch Ave. - N. Milwaukee River Pkwy. to N. 11th St. (WT410110638) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$55,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated

to be completed during the 2014 construction season.

W. Custer Ave. - N. 27th St. to 300 feet west of N. 27th St. (WT410110647) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$55,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2014 construction season.

N. Milwaukee River Pkwy. - 900 feet south of W. Lawn Ave. to 730 feet south of W. Lawn Ave. (WT410110639) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$31,000). The total estimated cost for this project including the requested amount is \$46,000. This project is anticipated to be completed during the 2014 construction season.

W. Oriole Dr. - N. 33rd St. to N. 35th St. (WT410110623) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$121,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2014 construction season.

W. Rochelle Ave. - N. 37th St. to N. 38th St. (WT410110640) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$45,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2014 construction season.

N. 23rd St. - 310 feet m/l south of W. Hope Ave. to W. Hope Ave. (SM495140005) File Number 140040: Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$52,000, Additional Funds). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed during the 2014 construction season.

N. 27th St. - W. Capitol Dr. to W. Roosevelt Dr. (SM499140103): N. 27th St. Bioswales. Water Quality Projects to meet TMDL Requirements. (Nonassessable TSS Removal Fund -- \$295,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2014 construction season.

N. 37th St. - W. Kiley Ave. to N. Rochelle Ave. (WT410110641) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$195,000). The total estimated cost for this project including the requested amount is \$220,000. This project is anticipated to be completed during the 2014 construction season.

Replace curb and gutter, sidewalk and concrete pavement where necessary, and grading. (Nonassessable Reconstruction Paving Fund -- \$45,000). The total estimated cost for this project including the requested amount is \$55,000. This project is anticipated to be completed during the 2014 construction season.

N. 27th St. - W. Center St. to W. Locust St. (SM495130017) File Number 121552: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$1,280,000). The total estimated cost for this project including the requested amount is \$1,300,000. This project is anticipated to be completed during the 2014 construction season.

N. 34th St. - W. Hadley St. to W. Locust St. (SM495100136) File Number 100013: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$125,000). The total estimated cost for this project including the requested amount is \$137,000. This project is anticipated to be completed during the 2014 construction season.

The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2014 construction season.
