THE CHAIR

A substitute ordinance relating to parking controls in various Aldermanic Districts. This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

“On the north side of West Lincoln Avenue from South 26th Street to South 28th Street from 3:30 PM to 5:30 PM Monday - Friday”

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of West Lincoln Avenue from South 26th Street to South Layton Boulevard from 3:30 PM to 5:30 PM Monday - Friday

On the west side of South 9th Street from a point 560 feet north of West Grange Avenue to a point 30 feet north thereof

Part 3. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

“On the west side of South 31st Street from West Montana Street to a point 290 feet north”

“On East Smith Street between South Graham Street and South Howell Avenue”

Part 4. Section 101-27-3-b-1 of the Code relating to Alternate Side Night Parking is amended by adding the following:

On West Maple Street from South 25th Street to South 26th Street

On South 26th Street from West Grant Street to West Lincoln Avenue

On South 34th Street from West Scott Street to West Greenfield Avenue
