This resolution authorizes acceptance of Sewer Easement SE-2725/Water Easement W.E.-904 at 1850 West Potawatomi Circle in the 8<sup>th</sup> Aldermanic District.

Whereas, The City of Milwaukee requested an easement needed for sewer and water facilities located at 1850 West Potawatomi; and

Whereas, The easement area is in lands owned by Forest County Potawatomi; and

Whereas, The land-owner is willing to grant Sewer Easement SE-2725/Water Easement W.E.-904 to the City giving the City permission to enter the property, and to construct, operate, maintain, inspect, and repair sewer and water facilities within the easement area on terms and conditions negotiated by the City's Department of Public Works, as reflected in the easement document that has been made part of this file; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper City officers, including the DPW Commissioner, are hereby authorized: (i) to accept Sewer Easement SE-2725/Water Easement W.E.-904, in the form and substance submitted to this file (or in substantially the same form and substance as submitted, and to effectuate the intent of this resolution); and (ii) to sign the easement and cause the same to be recorded in the Milwaukee County Register of Deeds Office.
