Resolution authorizing the Commissioner of Public Works to execute Project Agreements titled “State Municipal Agreement for a Local Bridge Project” with the Wisconsin Department of Transportation for rehabilitation of the North 51st Boulevard Bridge over Lincoln Creek and the reconstruction of the Port Washington Bridge over West Capitol Drive with local funds for estimated preliminary engineering costs of \$230,040 and \$426,420, respectively.

This Resolution authorizes the Commissioner of Public Works to execute Project Agreements with the Wisconsin Department of Transportation for rehabilitation of the North 51st Boulevard Bridge over Lincoln Creek and the reconstruction of the Port Washington Bridge over West Capitol Drive with local funds for estimated preliminary engineering costs of \$230,040 and \$426,420, respectively. Construction funds for these projects will be requested in future Common Council resolutions.

Whereas, Construction funding for these projects was applied for in the 2013-2018 State Municipal Agreement-Local Bridge Program solicitation but funding will not be available until 2015 at the earliest; and

Whereas, The City of Milwaukee would like to undertake preliminary engineering of the projects in 2014 so

contract documents will be available for bidding when the State Municipal Agreement-Local Bridge Program construction funding is available; and

Whereas, A State Municipal Agreement is required to allow state review on a locally funded design for a project not currently in an approved State Municipal Agreement-Local Bridge program; and

Whereas, Preliminary engineering has previously been set up for these projects but these project agreements will allow reimbursement of state review of the design; and

Whereas, The North 51st Boulevard Bridge project is scheduled for construction in 2015 and the Port Washington Bridge is scheduled for construction in 2016 pending State Municipal Agreement-Local Bridge program authorization and construction funds for these projects will be requested in separate resolutions; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works is hereby authorized to execute the agreements for the programming and design of the aforementioned projects with the Wisconsin Department of Transportation, copies of which are attached to Common Council Resolution File Number 131237, and are incorporated in this resolution by reference as though set forth in full; and, be it

Further Resolved, The City Engineer is hereby authorized and directed to approve and make periodic payments to the Wisconsin Department of Transportation upon receipt of invoices for the City's share of the costs of these projects.
