Resolution relative to application, acceptance and funding of the Meta House FamilyWorks Project Grant. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund the Meta House FamilyWorks Project from the U.S. Department of Health and Human Services Substance Abuse and Mental Health Administration in the amount of \$500,000. The purpose of the project is to partner with Meta House Inc. to increase its capacity to serve primarily African American women and address the many health disparities experienced by this population.

Whereas, The operation of this grant project from 06/01/04 to 05/30/05 would cost \$500,000 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the U.S. Department of Health and Human Services Substance Abuse and Mental Health Administration is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 030712 (Grant Ordinance); and, be it

1. Commit funds within the Project/Grant parent of the 2004 Special Revenue-Grant and Aid Projects fund, the following amounts for the project titled Meta House FamilyWorks Project:
