Substitute resolution relative to legislative bills.

Whereas, The Judiciary and Legislation Committee of the Common Council has recommended the following positions on the bills hereinafter listed and the Common Council being advised of said matters; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that it hereby approves the following legislative bill and instructs the Division of Intergovernmental Relations to appear before the proper committees to support such bill and use its best endeavors to have the same enacted into law, viz:

LRB-3953 **Counting individuals confined in state prison to determine population for redistricting purposes.**

SB-523 **Grants to schools to acquire proactive firearm detection software and making an appropriation.**

LRB-3661 **Creating a task force on missing and murdered African American women**

and girls.

Further Resolved, That the Common Council of the City of Milwaukee is opposed to the following legislative bills and hereby instructs the Division of Intergovernmental Relations to appear before the proper committees in opposition to

SB-471/AB-451 Exempting tobacco bars from the public smoking ban.

LRB-2829 Prohibited considerations in awarding state or local financial assistance.

SB-455/AB-457 Authorizing the Public Service Commission to regulate storm water utilities.

LRB-4389 Water and sewerage system connections and annexation of territory and extraterritorial zoning in certain towns.

LRB-2530 Prohibiting certain indemnification provisions in public contracts relating to design professional services.

SB-467/AB-486 Outdoor advertising signs that do not conform to local ordinances and that are affected by certain transportation-related projects.
