This resolution directs the Department of Neighborhood Services to fence the City-owned vacant lots at: 2908 N. 5th St., 2911 N. 5th St., 2915 N. 5th St., 2932 N. 5th St., and 2935 N. 5th St.

Whereas, The City of Milwaukee owns vacant lots at: $2908 \text{ N.} 5^{\text{th}} \text{ St.}$, $2911 \text{ N.} 5^{\text{th}} \text{ St.}$, $2915 \text{ N.} 5^{\text{th}} \text{ St.}$, $2932 \text{ N.} 5^{\text{th}} \text{ St.}$, and $2935 \text{ N.} 5^{\text{th}} \text{ St.}$; and

Whereas, The deserted and unprotected appearance of the lots attracts criminals intending to break the law while on the property; and

Whereas, These lots have been the site of robberies and other unlawful activities; and

Whereas, To correct the appearance of these lots for purposes of crime prevention and to deter public entrance, it is desirable to fence the lots on all sides; now, therefore, be it
