THE JUDICIARY AND LEGISLATION COMMITTEE

Substitute resolution authorizing the return of real estate located at 2303 North 46<sup>th</sup> Street, in the 17th Aldermanic District of the City of Milwaukee to its former owner upon payment of all city and county tax liens and any special improvement bonds, with all interest and penalty thereon and all costs as sustained by the City in foreclosing and managing said real estate. (James Rouse)

Permits return of property owned by the City under conditions imposed by Ordinance File Number 901739, passed by the Common Council on July 28, 1992.

Whereas, The property located at 2303 North  $46^{\rm th}$  Street, tax key number 328 -1258-X previously owned by James Rouse, has delinquent taxes for 2000 -

2001 plus a Special Improvement Bond, and was foreclosed upon pursuant to Sec. 75.521, Wis. Stats., and a fee simple absolute was obtained in favor of the City of Milwaukee dated November 4, 2002; and

Whereas, James Rouse would like to reclaim said property by paying all City and County real estate taxes, plus a Special Improvement Bond, accrued interest and penalties to date of payment, and all costs as sustained by the City in the foreclosing and management of said property since November 4, 2002; and

Whereas, The Department of Neighborhood Services indicates currently no unabated orders exist on this property. The applicant has not properly updated the property recording records with the Department for this property and 3402 N.  $46^{\rm th}$  St., 2766 N.  $19^{\rm th}$  St. and 2452 N.  $29^{\rm th}$  St. The Department has no objections to the return of 2303 N.  $46^{\rm th}$  Street provided the owner properly records all of these properties prior to its return; and

Whereas, The City Treasurer's records show outstanding 2000 - 2001 taxes, a special improvement bond, plus interest, penalties and costs; and

Whereas, The Department of City Development reports that this property is not suitable for use by a public agency or community based organization. Said property is occupied but no rent has been collected and administrative costs have been incurred totalling \$450; and

Whereas, The Health Department reported no outstanding orders or notices, and no clean up notices have been issued against this property under Section 80-8 or 17-12 in 2002 or thus far in 2003; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that in order to return the property at 2303 North  $46^{\rm th}$  Street, a cashier's check must be submitted in the amount indicated by the City Treasurer within forty-five (45) calendar days of the adoption of this resolution; and, be it

Further Resolved, That the City Attorney is then authorized to enter into a stipulation with the former owner to reopen and vacate the City's judgment in Milwaukee County Circuit Court Case No. 02-CV-006239 known as the 2002-03, In Rem Parcel 433 securing the court's order and recording said order with the Milwaukee County Register of Deeds; and, be it

Further Resolved, That if the above delinquent taxes, interest, and penalties are not paid within forty-five (45) calendar days of the adoption of this resolution, this process becomes null and void. CC CC
