### 140432 Substitute 1 THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$640,000 for a total estimated cost of these projects being \$7,579,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$640,000 with the total cost estimated to be \$7,579,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

#### 1st Aldermanic District

N. 41st St. - W. Green Tree Rd. to W. Cheyenne St. (WT410150661): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2015 construction season.

N. 41st St. - W. Vera Ave. to W. Good Hope Rd. (WT410150662): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$390,000. This project is anticipated to be completed during the 2015 construction season.

N. 44th St. - W. Hampton Ave. to W. Stark St. (WT410150657): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2015 construction season.

N. 47th St. (East Side) - W. Fairmount Ave. to W. Villard Ave. (WT410150656): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$290,000. This project is anticipated to be completed during the 2015 construction season.

W. Fond du Lac Ave. (South Side) - N. 68th St. to W. Stark St. (WT410150666): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2015 construction season.

W. Herbert Ave. - N. Strathmore Ave. to W. Tallmadge Pl. (WT410150664): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2015 construction season.

W. Kathryn Ave. - N. Strathmore Ave. to N. 72nd St. (WT410150665): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2015 construction season.

W. Medford Ave. - N. 70th St. to N. 71st St. (WT410150668): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2015 construction season.

N. Strathmore Ave. - W. Herbert Ave. to W. Sheridan Ave. (WT410150663): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$215,000. This project is anticipated to be completed during the 2015 construction season.

N. 72nd St. - W. Hampton Ave. to W. Fairmount Ave. (WT410150667): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$285,000. This project is anticipated to be completed during the 2015 construction season.

N. Franklin Pl. - N. Prospect Ave. to E. Ogden Ave. (WT410150653): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2015 construction season.

N. Marshall St. - E. Pleasant St. to E. Brady St. (WT410150669): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$195,000. This project is anticipated to be completed during the 2015 construction season.

W. Cameron Ave. - N. 103rd St. to N. 105th St. (WT410150678): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2015 construction season.

W. Chambers St. - N. 81st St. to N. 82nd St. (WT410150655): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2015 construction season.

W. Fairmount Ave. - N. 104th St. to N. 105th St. (WT410150680): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2015 construction season.

W. Harvest Ln. - N. 104th St. to N. 105th St. (WT410150682): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2015 construction season.

W. Lancaster Ave. - N. 103rd St. to N. 105th St. (WT410150679): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$145,000. This project is anticipated to be completed during the 2015 construction season.

N. 81st St. - W. Townsend St. to W. Keefe Ave. (WT410150654): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2015 construction season.

N. 104th St. - W. Harvest Ln. to W. Fairmount Ave. (WT410150681): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2015 construction season.

N. 105th St. - W. Stark St. to W. Lancaster Ave. (WT410150677): Relaying water main.

(Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$330,000. This project is anticipated to be completed during the 2015 construction season.

W. Fountain Ave. - N. Delta Pl. to N. 59th St. (WT410150675): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$410,000. This project is anticipated to be completed during the 2015 construction season.

W. Lincoln Ave. - S. 14th St. to S. 15th St. (SM495140061): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2015 construction season.

W. Maple St. - S. 8th St. to S. 12th St. (SM495140059): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). S. 12th St. - W. Burnham St. to W. Maple St. (SM495140058): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$181,000. This project is anticipated to be completed during the 2015 construction season.

S. 15th St. - W. Greenfield Ave. to W. Lapham Blvd. (WT410150674): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$220,000. This project is anticipated to be completed during the 2015 construction season.

#### 15th Aldermanic District

W. Center St. - N. 41st St. to N. Sherman Blvd. (SM495140060): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$289,000. This project is anticipated to be completed during the 2015 construction season.

W. Lloyd St. - N. 15th St. to N. 18th St. (SM495140062): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$299,000. This project is anticipated to be completed during the 2015 construction season.

N. 18th St. - W. Cherry St. to W. Lloyd St. (WT410140695): Repair 54-inch water main and seal. (Nonassessable Water Fund Budget Line 5010 -- \$15,000; Nonassessable Water Fund Budget Line 6410 -- \$15,000). The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2014 construction season.

N. 20th St. - W. Vine St. to W. Brown St. (WT410150670): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2015 construction season.

#### City of Greenfield

W. Cold Spring Rd. - S. 28th St. to 370 feet west of S. 64th St. (WT410140694): Water service alterations. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2014 construction season.
