Whereas, National League of Cities President James C. Hunt has appointed Ald. Joe Davis, Sr. Vice-Chair of the National League of Cities' Community and Economic Development Policy and Advocacy Committee; and

Whereas, The Committee develops policy positions and advocates on behalf of the nation's cities on national issues involving municipal government, including community development block grants, housing and economic development; and

Whereas, Participation on the Steering Committee will require the expenditure of funds for travel, lodging and related expenses; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Common Council authorizes the participation of Ald. Joe Davis, Sr. as a member and Vice-Chair of the National League of Cities Community and Economic Development Policy and Advocacy Committee; and, be it

Further Resolved, That the City Clerk is authorized to expend funds from the Economic Development

Committee Fund Special Purpose Account (Account Number 0001-1310-S123-006300) for travel, lodging and per diem expenses related to Ald. Davis' attendance and participation at meetings of the National League of Cities' Community and Economic Development and Advocacy Committee; and, be it

Further Resolved, That the authorized travel and expenditures shall be in accordance with all applicable provisions of s. 350-181 of the Milwaukee Code of Ordinances.
