SUBSTITUTE 1

THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations. -Analysis-

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

3rd Aldermanic District

E. Auer Ave. - N. Fratney St. to 100 ft. m/l east of N. Pierce St. (839-4884-9): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Booth St. - E. Concordia Ave. to 300 ft. m/l north of E. Concordia Ave. (839-1884-4): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Bremen St. - E. Burleigh St. to 250 ft. m/l north of E. Burleigh St. (839-9884-X): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

E. Burleigh St. - 120 ft. m/l east of N. Bremen St. to N. Bremen St. (839-6884-5): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Cambridge Ave. - E. Newport Ave. to E. Providence Ave. (875-0575-2): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (1999 Paving Program)

E. Chambers St. - 120 ft. m/l east of N. Weil St. to N. Weil St. (839-7884-3): Paving the roadway with concrete. Laying a concrete curb and

gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

E. Concordia Ave. - 200 ft. m/l east of N. Booth St. to N. Booth St. (839-2884-2): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Fratney St. - 200 ft. m/l south of E. Auer Ave. to E. Auer Ave. (839-5884-7): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Pierce St. - 450 ft. m/l south of E. Concordia Ave. to 100 ft. m/l south of E. Concordia Ave. (839-3884-0): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

N. Weil St. - E. Chambers St. to 320 ft. m/l north of E. Chambers St. (839-8884-1): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

3rd and 6th Aldermanic Districts

N. Holton St. - 100 ft. m/l south of E. Townsend St. to E. Townsend St. (839-0885-1): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

6th Aldermanic District

W. Hadley St. (N/S) at a point west of N. 5th St. [Including N. 5th St. (W/S) at a point north of W. Hadley St.] (994-0086-5): Laying a concrete curb and gutter. Laying concrete sidewalk. Removing and replacing driveway. Removing trees. Doing all the necessary grading pertaining to said work.

E. Townsend St. - N. Holton St. to 120 ft. m/l west of N. Holton St. (839-1885-X): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work including removal of abandoned railroad signals and safety devices and other obstructions in the right of way associated with railroad operations.

16th Aldermanic District

W. St. Paul Ave. (N/S) - N. 37th St. to N. 39th St. (839-0883-0): Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (1999 Paving Program)

;and, be it

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it
