Whereas, Existing funding will be insufficient and additional funding is necessary to fulfill our legal obligations through the remainder of the year including some additional expenditures for changed circumstances related to the Sewer Overflows Litigation and other unanticipated litigation; and

Whereas, It is in the City's best interest to continue to retain outside counsel and experts when necessary; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that \$85,000 be appropriated from the Common Council Contingent Fund No. 0001-9990-C001-006300 to the Outside Counsel/Expert Witness Fund 0001-1490-0001-S157-006300; and, be it
