Resolution directing the Department of City Development to prepare a resolution to vacate a portion of the east-west alley and a 7-foot wide portion of right-of-way along the west side of North 39th Street in the block bounded by West Lisbon Avenue, West Brown Street, North 39th Street and North 40th Street, in the 15th Aldermanic District.

This resolution directs the Department of City Development to prepare a resolution to vacate said portions of alley and street in accordance with vacation proceedings under power granted to the City of Milwaukee by Section 62.73, Wisconsin Statutes, and Section 308-28, Milwaukee Code of Ordinances. This vacation was initiated by the Department of City Development to accommodate the United Methodist Children's Services expansion including a community center and 24 housing units.

Whereas, It has been proposed by the Department of City Development that a portion of the east-west alley and a 7-foot wide portion of right-of-way along North 39th Street in the block bounded by West Lisbon Avenue, West Brown Street, North 39th Street and North 40th Street be vacated pursuant to the provisions of Section 62.73, Wisconsin Statutes; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Department of City Development is directed to prepare a resolution to vacate said portions of alley and street in accordance with Section 308-28 of the Milwaukee Code of Ordinances.
