THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$446,224.06 for a total estimated cost of these projects being \$4,527,724.06. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$446,224.06 with the total cost estimated to be \$4,527,724.06

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

4th Aldermanic District

N. Cass St. - E. State St. to E. Juneau Ave. (SM495120058): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$173,000. This project is anticipated to be completed during the 2013 construction season.

5th Aldermanic District

W. Beckett Ave. - N. 77th St. to W. Ruby Ave. (WT410130614): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2013 construction season.

W. Capitol Dr. - N. 84th St. to W. Grantosa Dr. (WT410130001): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,500; Nonassessable Water Fund Budget Line 6410 -- \$6,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2013 construction season.

W. Ruby Ave. - N. 77th St. to W. Beckett Ave. (WT410130613): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2013 construction season.

N. 77th St. - W. Beckett Ave. to W. Ruby Ave. (WT410130612): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2013 construction season.

N. 94th St. - W. Burleigh St. to W. Townsend St. (WT410130005): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$15,000; Nonassessable Water Fund Budget Line 6410 -- \$15,000). The total estimated cost for this project including the requested amount is \$440,000. This project is anticipated to be completed during the 2013 construction season.

8th Aldermanic District

W. Orchard St. - S. 31st St. to S. 32nd St. (SM495120055): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$35,000. This project is anticipated to be completed during the 2013 construction season.

S. 26th St. - W. Pierce St. to W. National Ave. (WT410130008): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2013 construction season.

W. Bolivar Ave. - S. Howell Ave. to S. 1st Pl. (SM495120050): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$128,000. This project is anticipated to be completed during the 2013 construction season.

W. Mallory Ave. - S. 22nd Pl. to S. 23rd St. (WT410130708): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2013 construction season.

S. 1st Pl. - W. Waterford Ave. to W. Bolivar Ave. (SM495120053): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$252,000. This project is anticipated to be completed during the 2013 construction season.

S. 1st St. - W. Waterford Ave. to W. Bolivar Ave. (SM495120052): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$64,000. This project is anticipated to be completed during the 2013 construction season.

S. 2nd St. - W. Waterford Ave. to W. Bolivar Ave. (SM495120051): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$253,000. This project is anticipated to be completed during the 2013 construction season.

S. 19th St. - W. Holt Ave. to W. Morgan Ave. (SM495120059): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$108,000. This project is anticipated to be completed during the 2013 construction season.

S. 22nd Pl. - W. Abbott Ave. to 325 feet south of W. Abbott Ave. (WT410130710): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2013 construction season.

S. 22nd St. - W. Abbott Ave. to W. Clayton Crest Ave. (WT410130709): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2013 construction season.

S. 23rd St. - W. Clayton Crest Ave. to W. Grange Ave. (WT410130706): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2013 construction season.

S. 23rd St. - W. Edgerton Ave. to 300 feet south of W. Abbott Ave. (WT410130705): (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$220,000. This project is anticipated to be completed during the 2013 construction season.

S. 27th St. - W. Edgerton Ave. to W. Clayton Crest Ave. (WT410130704): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2013 construction season.

S. Adams Ave. - E. Montana St. to E. Fremont Pl. (SM495120046): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$82,000. This project is anticipated to be completed during the 2013 construction season.

S. Kansas Ave. - E. Saveland Ave. to E. Warnimont Ave. (Portions in the City of St. Francis) (SM495120048): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$191,000. This project is anticipated to be completed during the 2013 construction season.
