Resolution granting an easement to the Time Warner Cable Corporation on City of Milwaukee owned property at 5701 West McKinley Avenue, and authorizing the proper City officers to execute the easement document.

This resolution grants an easement to Time Warner Entertainment Company LP, a Delaware Limited Partnership, d.b.a. Time Warner Cable for the installation and maintenance of underground and surface utility facilities at 5701 West McKinley Avenue (Milwaukee Water Works Hawley Road Water Tower).

Whereas, The Time Warner Cable Corporation provides communication services to the City of Milwaukee owned property at 5701 West McKinley Avenue (Milwaukee Water Works Hawley Road Water Tower property); and

Whereas, Said services are provided by underground and surface utility facilities located on said property; and

Whereas, The Time Warner Cable Corporation requires a permanent easement, as shown on Exhibit "B" of the attached easement document, on said property to install, maintain, and replace said facilities; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that an easement is granted to the Time Warner Cable Corporation and the proper City Officers are hereby authorized to execute the easement document, a copy of which is attached to and part of this resolution; and, be it

Further Resolved, That after said easement has been executed by the proper City Officers, it shall be forwarded to the Department of Public Works for further processing.
