THE CHAIR

A substitute ordinance relating to traffic controls in various Aldermanic Districts.

This ordinance establishes the above-mentioned traffic requirements

in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-9-1 of the Code relating to No Pedestrian Crossing is amended by adding the following:

The west crosswalk at the intersection of West Highland Avenue and North 10th Street

Part 2. Section 101-10-2 of the Code relating to No Turn on Red is amended by adding the following:

On East Brady Street at North Humboldt Avenue in all directions

Part 3. Section 101-11-1 of the Code relating to No Left Turns is amended by adding the following:

On North Warren Avenue at East Brady Street (Northbound)

Part 4. Section 101-12-4-a of the Code relating to Mandatory Turn Lanes is amended by striking the following:

"On West Washington Blvd. at North 60th Street Right Lane Must Turn Right Except Buses Westbound"

Part 5. Section 101-13-8 of the Code relating to School Speed 20 MPH is amended by adding the following:
