Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$4,707,000 for a total estimated cost of these projects being \$4,912,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$4,707,000. The total estimated cost of these projects is \$4,912,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

7th and 15th Aldermanic Districts

W. Hadley St. - 150' West of N. Sherman Blvd. to 50' East of N. Sherman Blvd. (SM495220045) File Number 220871: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$67,000). The total estimated cost of this project including the requested amount is \$77,000. This project is anticipated to be completed during the 2023 construction season.

### 8th Aldermanic District

S. 37th St. - W. Burnham St. to W. Grant St. (SM495220023) File Number 220618: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$713,000). The total estimated cost of this project including the requested amount is \$728,000. This project is anticipated to be completed during the 2023 construction season.

W. Becher St. - S. 36th St. to S. 37th St. (SM495220022) File Number 220618: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$109,000). The total estimated cost of this project including the requested amount is \$121,000. This project is anticipated to be completed during the 2023 construction season.

### 8th and 12th Aldermanic Districts

16th Street Viaduct over the Menomonee River (BR100230106) Installation of debris netting south of Canal Street. (City Share Nonassessable Structure Fund -- \$325,000). The total estimated cost for this project including the requested amount is \$325,000. This project is anticipated to be completed during the 2023 construction season.

### 11th Aldermanic District

W. Howard Ave. - S. 92nd St. to City Limits (Sponsored by the City of Greenfield) (ST211220261) File Number 221123: Concrete pavement maintenance. Replacing concrete curb and gutter as necessary. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$50,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2023 construction season.

### 13th Aldermanic District

S. 15th Pl. - 605+/- North of W. Dakota St. to W. Oklahoma Ave. (SM495220010) File Number 211481: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$718,000). The total estimated cost of this project including the requested amount is \$733,000. This project is anticipated to be completed during the 2023 construction season.

S. 15th St - 480' N. of W. Dakota St. to W. Manitoba St. (SM495210091) File Number 211199: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$786,000). The total estimated cost of this project including the requested amount is \$801,000. This project is anticipated to be completed during the 2023 construction season.

### 13th and 14th Aldermanic Districts

W. Manitoba Ave. - S. 15th St. to S. 15th Pl. (SM495210104) File Number 211199: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$147,000). The total estimated cost of this project including the requested amount is \$159,000. This project is anticipated to be completed during the 2023 construction season.

### 14th Aldermanic District

S. 14th St. - 650' +/- North of W. Dakota St. to W. Dakota St. (SM495210115) File Number 211343: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$224,000). The total estimated cost of this project including the requested amount is \$236,000. This project is anticipated to be completed during the 2023 construction season.

#### 15th Aldermanic District

N. 37th St. - W. Highland Blvd. to W. Juneau Ave. (SM495220056) File Number 221123: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$144,000). The total estimated cost of this project including the requested amount is \$156,000. This project is anticipated to be completed during the 2023 construction season.

N. 38th St. - W. Highland Blvd. to W. Juneau Ave. (SM495220055) File Number 221123: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$136,000). The total estimated cost of this project including the requested amount is \$148,000. This project is anticipated to be completed during the 2023 construction season.

N. Sherman Blvd. - W. Meinecke Ave. to W. Wright St. (SM495220035) File Number 220759: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$201,000). The total estimated cost of this project including the requested amount is \$213,000. This project is anticipated to be completed during the 2023 construction season.

N. Sherman Blvd. - W. North Ave. to W. Meinecke Ave. (SM495220034) File Number 220759: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$402,000). The total estimated cost of this project including the requested amount is \$417,000. This project is anticipated to be completed during the 2023 construction season.

Movable Bridge Upgrades (BR100230105) Movable bridge mechanical, hydraulic, and electrical upgrades (City Share Nonassessable Structure Fund -- \$100,000). The total estimated cost for this project is \$100,000. The engineering is anticipated to be completed during 2023.

Water Repairs/Distribution Referred. (WT410230840) File Number 221268: Water main repairs. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$230,000). The total estimated cost of this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2023 construction season.

Work by MWW Prior to Paving. (WT410230730) File Number 221268: Water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$85,000). The total estimated cost of this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2023 construction season.

Work Done by Contractor/Paving. (WT410230750) File Number 221268: Water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$135,000). The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2023 construction season.

Work by Done by Contractor/Sewer Alterations. (WT410230770) File Number 221268: Water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$135,000). The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2023 construction season.
