Whereas, Members of the Judiciary and Legislation Committee have reviewed the records relating to the claims of Nicholas Rummler in the amount of \$5,747.30, relating to vehicle damages resulting from an accident involving a City of Milwaukee Sanitation Department truck on December 11, 2023. Based on this review, members of the Committee, despite the recommendation of the City Attorney, recommended the claimant be reimbursed \$1,500.00 in payment of this claim; now, be it

Resolved, By The Common Council of the City of Milwaukee, that the proper city officers be and they hereby are authorized and directed to issue a city check in the total sum of \$1,500.00 payable to Nicholas Rummler, 2537 N Grant Boulevard, Milwaukee WI 53210, to reimburse him for the loss;

Further Resolved, That the check is to be delivered upon presentation of a proper release, approved by the City Attorney; said amount to be charged to Account No. 636506, Fund - 0001, Organization - 1490, Program - 2631, Sub Class - S118, Budget Year 2025. This resolution would release the City from any further liability arising from this incident.
