Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

6th Aldermanic District

E. Lloyd St. - N. Holton St. to 120 feet m/l east of N. Booth St. (SM495030196): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$7,000)

8th Aldermanic District

S. 25th St. - W. Mitchell St. to W. Burnham St. (SM495030192): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000)

12th Aldermanic District

S. 3rd St. - W. National Ave. to W. Mineral St. (SM495030194): Relaying combined sewer.
(Nonassessable Sewer Maintenance Relay Fund -- \$7,400)

W. Windlake Ave. - W. Becher St. to W. Grant St. (SM495030195): Relaying combined sewer.

17th Aldermanic District

W. North Ave. - N. 36th St. to N. 39th St. (SM495030193): Relaying combined sewer.
(Nonassessable Sewer Maintenance Relay Fund -- \$12,000)

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
