S. 60th St. at W. Forest Home Ave. (WT410081410) File Number 070266: Water main alteration. (Nonassessable Water Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2008 construction season.
