Whereas, The plaintiffs, The Catholic Mutual Relief Society of America and Blessed Savior Catholic Church, Case No. 16-CV-007142, have commenced a lawsuit against the City seeking damages of \$50,000.00 for damages sustained from the rupture of a municipal water line flooding Blessed Savior Catholic School at 4059 North 64th Street on March 6, 2014; and

Whereas, A settlement favorable to all parties has been reached; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to settle this lawsuit; now, therefore, be it
