This resolution authorizes the proper City officers to accept and execute an easement to Ameritech Wisconsin to install and maintain service over, across and under certain City-owned land. Whereas, In order to accomplish this service Wisconsin Bell, Inc., d/b/a Ameritech Wisconsin has submitted an easement agreement granting them the right to enter upon City-owned property at 4028

West Congress Street; and

Whereas, The terms of said easement agreement are set out and attached to this file and approved as to content by the City Engineer and as to form by the Office of the City Attorney; now, therefore, be it
