Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$6,193,000 for a total estimated cost of these projects being \$6,571,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$6,193,000. The total estimated cost of these projects is \$6,571,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

N. Maryland Ave. - E. Newport Ave. to E. Edgewood Ave. (SM495140078) File Number 140818: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$96,000). The total estimated cost for this project including the requested amount is \$108,000. This project is anticipated to be completed during the 2015 construction season.

#### 4th Aldermanic District

E. Clybourn St. - N. Milwaukee St. to N. Van Buren St. (WT410140620) File Number 140280: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$20,000; Nonassessable Water Fund Budget Line 6410 -- \$330,000). The total estimated cost for this project including the requested amount is \$365,000. This project is anticipated to be completed during the 2015 construction season.

E. Clybourn St. - N. Van Buren St. to N. Harbor Dr. (WT410150704) File Number 150231: Water main relay and extension. (Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$313,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2015 construction season.

E. Michigan St. - N. Cass St. to 210 feet east of N. Cass St. (WT410150696) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$162,000). The total estimated cost for this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2015 construction season.

#### 5th Aldermanic District

Menomonee River Group - Bioswale Project: N. Menomonee River Pkwy. - N. Swan Blvd. to W. Burleigh St. (Portions in the City of Wauwatosa) (SM499150108) File Number 150616: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$29,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2015 construction season.

#### 6th Aldermanic District

W. Atkinson Ave. - N. 11th St. to N. 19th St. (SM495140083) File Number 140818: Relaying combined, sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$858,000). The total estimated cost for this project including the requested amount is \$870,000. This project is anticipated to be completed during the 2015 construction season.

W. Keefe Ave. - N. 18th St. to N. 22nd St. (SM495100149) File Number 100960: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$2,146,000). The total estimated cost for this project including the requested amount is \$2,161,000. This project is anticipated to be completed during the 2015 construction season.

N. Richards St. - E. Capitol Dr. to E. Hope Ave. (SM495140092) File Number 141120: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$98,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2015 construction season.

#### 8th Aldermanic District

S. 34th St. - W. Arthur Ave. to W. Pabst Ave. (SM495120095) File Number 140433: Relaying sanitary

sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$50,000, Additional Funds). The total estimated cost for this project including the requested amount is \$236,000. This project is anticipated to be completed during the 2015 construction season.

#### 12th Aldermanic District

W. Becher St. - S. 16th St. to S. 20th St. (SM495140106) File Number 141399: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$975,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2015 construction season.

W. Maple St. - S. 8th St. to S. 12th St. (SM495140059) File Number 140432: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$625,000). The total estimated cost for this project including the requested amount is \$640,000. This project is anticipated to be completed during the 2015 construction season.

S. 6th St. - W. Lapham Blvd. to 200 feet m/l north of W. Mitchell St. (SM495140080) File Number 140818: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$103,000). The total estimated cost for this project including the requested amount is \$118,000. This project is anticipated to be completed during the 2015 construction season.

S. 11th St. - W. Arthur Ave. to W. Harrison Ave. (SM495140076) File Number 140818: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$171,000). The total estimated cost for this project including the requested amount is \$186,000. This project is anticipated to be completed during the 2015 construction season.

S. 12th St. - W. Burnham St. to W. Maple St. (SM495140058) File Number 140432: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$202,000). The total estimated cost for this project including the requested amount is \$217,000. This project is anticipated to be completed during the 2015 construction season.
