THE CHAIR

Resolution determining it necessary to make various assessable public improvements at various locations. (Infrastructure Services Division)

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

8th Aldermanic District

Alley between W. Evergreen Ln., S. Layton Bl., W. Pierce St. and S. 28th St. (ST212020111): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$1,000)

11th Aldermanic District

Alley between W. Arthur Ave., W. Harrison Ave., S. 71st St., S. 72nd St. and the City Limits.

(ST212020112): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$1,000)

12th Aldermanic District

Alley between W. Maple St., W. Mitchell St., S. 5th St. and S. 6th St. (ST212020113): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$1,000)

Alley between W. Mineral St., W. Scott St., S. 20th St. and S. 21st St. (ST212020114): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$1,000)

Alley between W. Mineral St., W. Walker St., S. 15th St. and S. 16th St. (ST212020115): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$1,000); and, be it

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
