The City cost of the projects approved by this resolution is estimated to be \$50,000. The total estimated cost of these projects is \$650,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

City Wide

2010 Indirect Account/Engineering Studies throughout the City of Milwaukee (SM495100001) File Number 090971: (Nonassessable Sewer Maintenance Relay Fund -- \$50,000, Additional Funds). The total estimated cost for this project including the requested amount is \$650,000. This project is anticipated to be completed during the 2011 construction season.

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is authorized and directed to proceed with said work; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it
