THE CHAIR

A substitute ordinance relating to parking controls in various Aldermanic Districts. This ordinance establishes the above-mentioned parking requirements in various parts of the City. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the west side of North 23rd Street from a point 180 feet north of West Purdue Street to a point 25 feet north thereof

On the south side of West Legion Street from South 24th Street to South 25th Street from 2:00 AM to 6:00 AM

On West Moltke Avenue from a point 225 feet east of North 72nd Street to a point 40 feet east thereof

On the west side of North 72nd Street from West Burleigh Street to 60 feet south

Part 2. Section 101-23-4-c of the Code relating to One-Hour Parking is amended by adding the following:

On the east side of North Commerce Street from a point 80 feet north of East North Avenue to a point 90 feet north thereof

Part 3. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

“On south side of West Meinecke Avenue from North Stanley Place east to the end of the street”

“On North Farwell Avenue from East Lafayette Place to East Kane Place”

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by adding the following:

On the west side of North Farwell Avenue from East Irving Place to East Lafayette Place

On the east side of North Farwell Avenue from a point 150 feet south of East Irving Place to East Kane Place

On the east side of North Farwell Avenue from a point 120 feet north of East Irving Place to East Lafayette Place

Part 5. Section 101-32-3-d-2 of the Code relating to Two-Hour Meter Parking is amended by adding the following:

On the west side of North Farwell Avenue from East Kane Place to East Irving Place

On the east side of North Farwell Avenue from East Irving Place to a point 150 feet south

On the east side of North Farwell Avenue from a point 40 feet north of East Irving Place to a point 80 feet north thereof

Part 6. Section 101-24-1 of the Code relating to Tow-away Zones is amended by adding the following:

On North Downer Avenue from East Kenwood Boulevard to East Edgewood Avenue
