Resolved, By the Common Council of the City of Milwaukee, that after December 15, 1997, and upon receipt of the tax bills for listed property from the City Treasurer, the Department of Public Works shall process the necessary documents to have checks issued to the City Treasurer in the amounts listed to pay the 1997 special assessment installments so indicated for confirmed worthy indigent resident property owners:
