### THE CHAIR

City Wide (ST280030100): General engineering for the Underground Conduit System Facilities in conjunction with 2003 Capitol Improvement Program (Underground Conduit Fund -- \$30,000)

City Wide (ST280030200): Major conduit installations at various locations. (Underground Conduit Fund -- \$459,000)

City Wide (ST280030300): Alterations and adjustments of underground conduit and manholes at various locations. (Underground Conduit Fund -- \$50,000)

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
