Substitute resolution approving an intergovernmental cooperation agreement between the City of Milwaukee and the State of Wisconsin relating to the acquisition by the City Clerk’s Office License Division of the Department of Regulation and Licensing’s Integrated Credentialing and Enforcement software.

This resolution approves an intergovernmental cooperation agreement between the City of Milwaukee and the Wisconsin Department of Regulation and Licensing relating to the acquisition by the City Clerk’s License Division of the Wisconsin Department of Regulation and Licensing’s Integrated Credentialing and Enforcement software, at no cost to the City.

Whereas, The City Clerk’s License Division believes that Wisconsin Department of Regulation and Licensing’s Integrated Credentialing and Enforcement (ICE) software could eventually meet its needs for a licensing information system; and

Whereas, The City Clerk’s Office desires to enter into an intergovernmental cooperation license agreement with the Wisconsin Department of Regulation and Licensing relating to ICE under which the department will grant a non-exclusive perpetual license to the City to access, use and benefit from

the ICE code, database tables, documentation and other information and materials necessary for the use of the ICE software, at no cost to the City; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the intergovernmental agreement between the City of Milwaukee and the Wisconsin Department of Regulation and Licensing relating to the Integrated Credentialing and Enforcement software, a copy of which is attached to this file, is approved; and, be it

Further Resolved, That the appropriate City officials are authorized to execute the agreement on behalf of the City; and, be it

Further Resolved, That the agreement is subject to the City Attorney's review and approval and any non-substantive change made by the City Attorney.
