W. Capitol Dr. (Southside) - N. 82nd St. to N. 84th St. (WT410230625) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$275,000). The total estimated cost of this project including the requested amount is \$290,000. This project is anticipated to be completed during the 2023 construction season.

E. Locust St. - N. Palmer St. to 65' +/- East of N. Richards St. (SM495230014) File Number 230577: Relaying combined sewer and lining. (Nonassessable Sewer Maintenance Relay Fund --\$282,000).
