Substitute resolution to review and approve modifications to the contract used by the Community Block Grant Administration for 2006 community development activity and to authorize execution of contracts and subcontracts by City departments.

This resolution authorized and approves modifications to the contract to be used by the Community Block Grant Administration for 2006 community development activity; and authorized the execution of subcontracts and contracts by City departments receiving Community Development Block Grant funding in 2006.

Whereas, The Common Council of the City of Milwaukee has previously approved funding recommendations for the City's 2006 Community Development Block Grant program in Resolution No. 050558, 050841, 050842, 050843, 050844, 050845, 050846, (hereinafter referred to as the "2006 CDBG Funding Resolutions"); and

Whereas, Pursuant Common Council Resolution No. 74-92-5v, the Common Council now wishes to make certain modifications to the form of contract to be used in the implementation of the CDBG program for 2006; to authorize the execution of contracts and subcontracts by such City departments; and to authorize a Interdepartmental Cooperation Agreement to be executed by CBGA and each City department which received CDBG funding in 2006; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the form of contract for use in

implementation of the 2006 Community Development Block Grant program, with entities other than City departments or agencies receiving CDBG funds, in the form on file with the Common Council in Resolution No. 050841, 050842, 050843, 050844, 050845, and 050846 (Form CDA-8, Contract for Services and Vendors) is hereby approved, subject to such revisions and modifications as may be required from time to time by the City Attorney; and

Further Resolved, That the form of contract for use in implementation of the 2006 Community Development Block Grant program by City departments and agencies receiving Community Development Block Grant funds, in the form on file with the Common Council in Resolution No. 050841, 050842, 050843, 050844, 050845, and 050846 (Interdepartmental Cooperation Agreement) is also hereby approved, subject to such revisions and modifications as may be required from time to time by the City Attorney; and

Further Resolved, That the various City departments identified in the 2006 CDBG Funding Resolutions (including the City Attorney, the City Comptroller, the Department of City Development, the Department of Neighborhood Services, the Health Department, the Department of Public Works, Milwaukee Fire Department, Milwaukee Police Department, Milwaukee Public Library, Redevelopment Authority, and the Department of Administration), are hereby authorized to enter into such contracts and subcontracts as may be required within the limits of the respective approved project budgets set forth in the 2006 CDBG Funding Resolutions, subject to the terms of the Interdepartmental Cooperation Agreement referred to in the preceding paragraph and entered into between CBGA and each such City department.
