Ordinance File Number 901739, passed by the Common Council on July 28, 1992.

Whereas, The property located 4131 N. Green Bay Road, tax key number 243-0004-0 previously owned by True Faith Church the Way of Holiness Inc., has delinquent taxes for 1998 - 2000 and was foreclosed upon pursuant to Sec. 75.521, Wis. Stats., and a fee simple absolute was obtained in favor of the City of Milwaukee dated July 30, 2001; and

Whereas, True Faith Church, would like to reclaim said property by paying all City and County real estate taxes, plus accrued interest and penalties to date of payment, and all costs as sustained by the City in the foreclosing and management of said property since July 30, 2001; and

Whereas, The Department of Neighborhood Services indicates currently no unabated orders exist on this property. However this property has not been properly recorded with the Department of Neighborhood Services. The property must be recorded prior to its return; and

Whereas, The City Treasurer's records show outstanding 1998 - 2000 taxes, plus interest, penalties and costs; and

Whereas, The Department of City Development reports that this property is not suitable for use by a public agency or community based organization. Said property is occupied but no rent has been collected and administrative costs have been incurred totalling \$450; and

Whereas, The Health Department reported no outstanding orders or notices, and no clean up notices have been issued against this property under Section 80-8 or 17-12 in 2000 or thus far in 2001; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that in order to return the property at 4131 N. Green Bay Road, a cashier's check must be submitted in the amount indicated by the City Treasurer within forty-five (45) calendar days of the adoption of this resolution; and, be it

Further Resolved, That the City Attorney is then authorized to enter into a stipulation with the former owner to reopen and vacate the City's judgment in Milwaukee County Circuit Court Case No. 01-CV-002799 known as the 2001-1, In Rem Parcel 170, securing the court's order and recording said order with the Milwaukee County Register of Deeds; and, be it

Further Resolved, That if the above delinquent taxes, interest, and penalties are not paid within forty-five (45) calendar days of the adoption of this resolution, this process becomes null and void. CC CC
