Resolution approving Three Year Harbor Development Statement of Intentions for the Port of Milwaukee. The Wisconsin Dept. of Transportation, in accord with State Statute, requires a Statement of Project Intentions from Local units of government intending to apply for Federal and/or State aid for harbor-related improvements which are in the best interest of the Port of Milwaukee, City of Milwaukee; and, be it

Resolved, That the Port of Milwaukee has carefully reviewed the estimated project costs, funding sources, physical location and alternatives to the proposed projects; and, be it

Further Resolved, That this Three-Year Harbor Statement of Intentions is used by the Wisconsin Department of Transportation for planning purposes only and is not a petition for Federal and/or State aid; and, be it

Further Resolved, That the Board of Harbor Commissioners approved the Three-Year Harbor Statement of Intentions at its meeting on January 17, 2002; and, be it

Further Resolved, That all projects included in the three-year program are contingent upon future Common Council approval of each project prior to proceeding with the project; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Three-Year Harbor Statement of Intentions attached to this file is approved.
