THE CHAIR

Resolution determining it necessary to make various assessable public improvements at various locations. (Infrastructure Services Div.) -Analysis-

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

3rd Aldermanic District

Alley between E. Auer Ave., N. Booth St., E. Concordia Ave., N. Pierce St. and Soo Line Railroad Right-of-Way (880-0819-8): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

4th Aldermanic District

Alley between N. Broadway, E. Clybourn St., E. Michigan St. and N. Water St. (880-0824-5): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

5th Aldermanic District

Alley between W. Auer Ave., W. Concordia Ave., N. 89th St. and N. 90th St. (880-0821-9): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

6th Aldermanic District

Alley between W. Auer Ave., W. Ring St., N. 2nd St. and N. 3rd St. (880-0822-4): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

Alley between E. Center St., E. Clarke St., N. Fratney St. and N. Pierce St. (N-S Leg) (880-0826-6): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

S. 19th St. - W. Burnham St. to W. Mitchell St. (870-0803-4): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

10th Aldermanic District

Alley between W. Auer Ave., W. Concordia Ave., N. 20th St. and N. 21st St. (880-0735-1): Paving the alley with asphalt. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

Alley between W. Concordia Ave., W. Townsend St., N. 35th St. and N. 36th St. (880-0827-1): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

12th Aldermanic District

Alley between W. National Ave., W. Pierce St., S. 2nd St. and S. 3rd St. (880-0831-3): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

13th Aldermanic District

Alley between W. Bolivar Ave., W. Whitaker Ave., S. 16th St. and S. 20th St. (N-S Leg and westerly portion of E-W Leg) (880-0823-X): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

S. Lincoln Memorial Dr. - 2000 ft. m/l south of E. Jones St. to 450 ft. m/l north of E. Jones St. (874-0756-9): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work.

Alley within W. Elliott Cr.; west of N. 58th St. and south of W. North Ave. (880-0828-7): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

17th Aldermanic District

Alley between W. Meinecke Ave., W. North Ave., N. 10th St. and N. 11th St. (880-0830-8): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

Alley between W. Meinecke Ave., W. North Ave., N. 11th St. to N. 12th St. (889-0893-7): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to
