Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations. -Analysis-

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

E./W. Mineral St. - 155 ft. m/l east of S. Barclay St. to S. 5th St. (877-0890-X) File Number 961238: Concrete pavement reconstruction, replace all curb and gutter and driveway approaches, replace sidewalk where needed, sodding, and grading. (Nonassessable Reconstruction Paving Fund 31-523---211-0001 -- \$220,625; Assessable Reconstruction Paving Fund 71-523---211-0001 -- \$54,735)

13th Aldermanic District

W. Ramsey Ave. - S. 13th St. to S. 20th St. (837-0877-3) File Number 960294: New asphalt pavement rural cross- section construction, place curb and gutter, sidewalk and driveway approaches as necessary, sodding, and grading. (Nonassessable New Paving Fund 31-523---210-0001 -- \$191,060; Assessable New Paving Fund 71-523---210-0001 -- \$75,445)

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital purpose subaccounts; and, be it

Further Resolved, That the projects do not involve any parcels of land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That project W. Ramsey Ave. (837-0877-3) shall be financed with a combination of 1997 and 1998 Reconstruction Paving Funds, however, all remaining 1997 Funds shall be used for said project prior to any 1998 Fund expenditures; and, be it

Further Resolved, That project E./W. Mineral St. (877-0890-X) will be billed after January 1, 1999, but not before 12 months after the project contract has been completed; and, be it

Further Resolved, That project W. Ramsey Ave. (837-0877-3) will be billed after January 1, 2000, but not before 12 months after the project contract has been completed.
