THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$232,000 for a total estimated cost of these projects being \$4,196,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$232,000 with the total cost estimated to be \$4,196,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

E. Belleview Pl. - N. Maryland Ave. to N. Stowell Ave. (SM495220051) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$274,000. This project is anticipated to be completed during the 2023 construction season.

6th Aldermanic District

W. Concordia Ave. - N. 22nd St. to 155' +/- East of N. 22nd St. (SM495220047) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$10,000). The total estimated cost of this project including the requested amount is \$51,000. This project is anticipated to be completed during the 2023 construction season.

N. Hubbard St. - E. Wright St. to E. Center St. (SM495220050) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$15,000). The total estimated cost of this project including the requested amount is \$363,000. This project is anticipated to be completed during the 2023 construction season.

#### 7th Aldermanic District

N. 27th St. - W. Keefe Ave. (EXT) to W. Nash St. (SM495220042) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$298,000. This project is anticipated to be completed during the 2023 construction season.

#### 7th and 15th Aldermanic Districts

W. Hadley St. - 150' West of N. Sherman Blvd. to 50' East of N. Sherman Blvd. (SM495220045) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$10,000). The total estimated cost of this project including the requested amount is \$71,000. This project is anticipated to be completed during the 2023 construction season.

#### 8th Aldermanic District

S. 35th St. - W. Lincoln Ave. to W. Pabst Ave. (SM495220052) Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund - \$15,000). The total estimated cost of this project including the requested amount is \$632,000. This project is anticipated to be completed during the 2023 construction season.

#### 11th Aldermanic District

Alley North of W. Burdick Ave. - S. 89th St. to S. 91st St. (SM495220044) Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$182,000. This project is anticipated to be completed during the 2023 construction season.

W. Burdick Ave. - S. 89th St. to W. Burdick Ave./W. Holt Ave. (SM495220043) Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$139,000. This project is anticipated to be completed during the 2023 construction season.

#### 13th Aldermanic District

W. Grange Ave. - 900' East of S. 20th St. to S. 27th St. (WT410200608) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$45,000 additional funds). The total estimated cost of this project including the requested amount is \$935,000. This project is anticipated to be completed during the 2023

construction season.

14th Aldermanic District

S. Herman St. - E. Oklahoma Ave. to E. Euclid Ave. (SM495220046) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$182,000. This project is anticipated to be completed during the 2023 construction season.

15th Aldermanic District

N. 25th St. - W. Galena St. to W. Lisbon Ave. (WT410220617) File Number 201552: Relaying water main and lead replacement of service. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$15,000 additional funds). The total estimated cost of this project including the requested amount is \$160,000. This project is anticipated to be completed during the 2023 construction season.

N. 38th St. - 150' South of W. Roberts St. to W. Roberts St. (SM495220048) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2023 construction season.

W. Roberts St. - N. 37th St. to N. 40th St. (SM495220049) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$15,000). The total estimated cost of this project including the requested amount is \$304,000. This project is anticipated to be completed during the 2023 construction season.

S. 27th St. (West Side) - W. Abbott Ave. to W. Grange Ave. (WT410200607) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$35,000 additional funds). The total estimated cost of this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2023 construction season.
