Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,260,000 for a total estimated cost of these projects being \$5,621,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,260,000. The total estimated cost of these projects is \$5,621,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

Alley between W. Fairmount Ave., N. 51st St. and N. 53rd St. (SM499180006): File Number 171854: Install permeable pavers (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$129,000). The total estimated cost for this project including the

requested amount is \$130,000. This project is anticipated to be completed during the 2018 construction season.

N. 27th St.-- W. Capitol Dr. to W. Roosevelt Dr. (SM499180008) File Number 171854: Bioretention maintenance contract (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$20,000). The total estimated cost for this project including the requested amount is \$21,000. This project is anticipated to be completed during the 2018 construction season.

#### 3rd Aldermanic District

E. Bradford Ave. - N. Frederick Ave. to N. Maryland Ave. (SM495170046): File Number 170392: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$97,000). The total estimated cost for this project including the requested amount is \$109,000. This project is anticipated to be completed during the 2018 construction season.

#### 4th Aldermanic District

N. James Lovell St. - 215' South of W. State St. to W. State St. (SM495160062) File Number 170143: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000 additional funds). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2018 construction season.

W. Vliet St.-- N. 12th St. to N. 27th St. (WT410180007) File Number 170019: Relay and abandonment of water main. (Nonassessable Water Fund Budget Line 5010 -- \$11,000; Nonassessable Water Fund Budget Line 6410 -- \$2,549,000). The total estimated cost for this project including the requested amount is \$2,650,000. This project is anticipated to be completed during the 2018 construction season.

E. Wisconsin Ave. - N. Water St. to N. Broadway Ave. (SM495160078) File Number 160797: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$43,000). The total estimated cost for this project including the requested amount is \$58,000. This project is anticipated to be completed during the 2018 construction season.

N. 8th St. - a point south of W. State St. to W. State St. (ST211180182): File Number 171591: Concrete pavement reconstruction, replace curb and gutter and walk as necessary. (Nonassessable Reconstruction Paving Fund - \$25,000 additional funds). The total estimated cost of this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2018 construction season

N. 33rd St. - W. Clybourn St. to 250' N. of W. St. Paul Ave. (SM495170037) File Number 170278: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$75,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2018 construction season

#### 5th Aldermanic District

Alley between W. Burleigh St., W. Chambers St., N. 90th St., and N. 91st St. (SM499180007) File number 171854: Install permeable pavers; (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$114 ,000). The total estimated cost for this project including

the requested amount is \$115,000. This project is anticipated to be completed during the 2018 construction season.

#### 7th and 15th Aldermanic Districts

N. Sherman Blvd. - W. North Ave. to W. Congress St. (SM499180009) File Number 171854: Bioretention maintenance contract (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements --\$ 44,000). The total estimated cost for this project including the requested amount is \$45,000. This project is anticipated to be completed during the 2018 construction season.

#### 8th Aldermanic District

W. Lincoln Ave.-- South side at S.37th St. (WT410170696) File Number 170991: Valve replacement and abandon main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$82,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2018 construction season.

#### 11th Aldermanic District

S.60th St. - W. Morgan Ave. to W. Kinnickinnic River Pkwy (SM499180114) File Number 171584: Install Bioswales. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$70,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2018 construction season.

#### 12th Aldermanic District

W. Oregon St. - Alley W. Oregon St. to 125' of W. Oregon St. (SM492180010): number Combined sewer relay and lining. (Nonassessable Developer Sewer Fund -- \$33,000). The total cost for this project including the requested amount is \$33,000. This project is anticipated to be completed during the 2018 construction season.

#### City Wide

Crackfilling of various streets by contract (ST211180169) File Number 171479: (Nonassessable Reconstruction Paving Fund -- \$490,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2018 construction season.

Handicap Ramp work to meet ADA requirements - High Impact 2018 Projects -- second contract (ST216180108) File Number 171591: Install curb and gutter and walk as necessary; (Nonassessable High Impact Streets -- \$1,450,000). The total estimated cost for this project including the requested amount is \$1,500,000. This project is anticipated to be completed during the 2018 construction season.
