 -Analysis-

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

E. North Ave. - N. Prospect Ave. to the Milwaukee River (Including N. Farwell Ave. - 305 ft. m/l north of E. Windsor Pl. to E. North Ave., N. Prospect Ave. - 100 ft. m/l north of E. Windsor Pl. to E. North Ave., E. Ivanhoe Pl. - N. Prospect Ave. to E. North Ave., and E. Kenilworth Pl. - N. Prospect Ave. to E. North Ave.) UR04082000 (842-0077-4): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (2000 Paving Program)
