THE CHAIR  
Substitute ordinance relating to release of public passenger vehicle permit to authorized representative of permittee.

100-50-3-c cr

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 100-50-3-c of the code is created to read:

**100-50. Public Passenger Vehicle Permits.**

**3. PERMIT.**

c. Authorized Representative. If a permittee first files a statement with the city clerk signed in the presence of a notary public designating an individual who is authorized to represent the permittee, the authorized representative may pick up from the city clerk a permit issued to the permittee after the permittee:

c-1. Has filed an affidavit with the city clerk for a duplicate permit.

c-2. Has successfully completed an inspection for the replacement of a vehicle.

c-3. No permit shall be released to any individual who is authorized under the provisions of this subsection to represent the permittee without the city clerk first securing 2 adequate items of identification from the authorized representative.
