Cambridge Ave. (ST21100149) File Number 911748: Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$74,400; Nonassessable Reconstruction Paving Fund -- \$131,400)

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the City Engineer and the Commissioner of Public Works are hereby authorized to negotiate and enter into an agreement with the State of Wisconsin, Department of Transportation for the City to undertake construction management duties on the following projects: W. Fond du Lac Ave. (ST30180701) and E. Bay St. (ST30681901); and, be it

Further Resolved, That the City Engineer is authorized and directed to approve and make periodic payments to the State of Wisconsin, Department of Transportation after receipt of invoices from said State for the City's share of the costs for said projects: W. Fond du Lac Ave. (ST30180701) and E. Bay St. (ST30681901); and, be it

Further Resolved, That upon the completion of projects: W. Fond du Lac Ave. (ST30180701) and E. Bay St. (ST30681901) and a determination of the actual costs, it is understood that if the City of Milwaukee's share is less than the amount previously paid, the difference will be refunded to said City; and, be it

Further Resolved, That projects: E. Windsor Pl. (ST21100149), Alley W. Cherry St. (ST212010133), Alley W. Mt. Vernon Ave. (ST21210119), W. Fond du Lac Ave. (ST30180701), E. Bay St. (ST30681901), and Alley W. Garfield Ave. (ST212010139) will be billed after January 1, 2003, but not before 12 months after the project contract has been completed.
