Resolution authorizing and directing the Commissioner of Public Works to execute Revised Project Agreements titled "State/Municipal Agreement for a Highway Improvement Project" with the Wisconsin Department of Transportation (WISDOT) to include updated design and construction costs for the replacement of several local bridges with 80% Federal and State aid under the Local Bridge Replacement Program. (Infrastructure Services Division)

This resolution authorizes and directs the Commissioner of Public Works to execute revised project agreements with the WISDOT to include updated design and construction costs for the replacement of several local bridges with 80% Federal and State aid under the Local Bridge Replacement Program. This resolution also directs the City Comptroller to transfer funds and establish project/grant chartfield values for the increased preliminary engineering costs for these projects. The total revised estimated construction cost for the projects is \$7,275,000 of which the City's share is \$1,455,000. The revised estimated design cost for the projects is \$1,694,000, of which the City's share is \$338,800.

Whereas, The Common Council has previously adopted resolutions authorizing and directing the Commissioner of Public Works to execute Project Agreements with WISDOT for the design and replacement of the following local bridges with 80% Federal and State aid under the Local Bridge Replacement Program:

W. Bradley Road over Little Menomonee River, Resolution File Number 881685, adopted December 20, 1988

N. Granville Road Bridge over Little Menomonee River, Resolution File Number 920154 adopted June 16, 1992

W. Highland Boulevard Bridge over Canadian Pacific Railroad, Resolution File Number 861643, adopted January 13, 1987

N. Humboldt Avenue Bridge over Milwaukee River, Resolution File Number 991981, adopted May 19, 2000

S. 29th Street Bridge over Union Pacific Railroad, Resolution File Number 950846, adopted October 17, 1995

; and

Whereas, Preliminary engineering activities have begun and the design and construction costs for the bridge replacements have increased from the original agreements; and

Whereas, The revised project agreements with the updated design and construction costs has been received from the WISDOT to be executed by the City of Milwaukee for the replacement of several local bridges with 80% Federal and State aid under the Local Bridge Replacement Program; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works is hereby authorized and directed to execute the revised project agreements for the replacement of several local bridges with 80% Federal and State aid under the Local Bridge Replacement Program, copies of which are attached to Common Council Resolution File Number 041494; and are incorporated by reference as though set forth in full; and, be it

Further Resolved, That the Commissioner of Public Works is hereby authorized and directed to undertake, or to engage a consultant to undertake, preliminary engineering for the replacement of several local bridges and to reimburse the WISDOT for preliminary engineering costs they incur for the improvement; and, be it

Further Resolved, That the City Comptroller is hereby authorized to create within the Capital Improvement Fund, Grant and Aid Projects, the necessary Project/Grant Chartfield values for preliminary engineering for the project (Expenditure) and transfer to any of these accounts the amount required under the grant agreement and City Accounting Policy but not to exceed a 10 percent increase of the total amount for the grantor's share and local share or \$5,000, whichever is greater, as follows:
