Whereas, Milwaukee's General Mitchell Air National Guard Base would be a fitting host for the KC-46 "Pegasus" aircraft, given the facility's strategic advantages and ongoing infrastructure developments; and

Whereas, Mitchell International Airport, also known as Mitchell Field, is situated in the Northern Tier base, which provides the 128<sup>th</sup> Air Refueling Wing with critical access for homeland defense and global reach missions, while also offering local airspace alongside the 115<sup>th</sup> Fighter Wing and the Volk training center for the annual Northern Lightning training exercise; and

Whereas, The 128<sup>th</sup> Air Refueling Wing's modernized facilities, such as the new alert facility, refurbished operations building, small air terminal, health clinic, fire station, and a recently inaugurated sensitive compartmented information facility, provide an accommodating environment for the KC-46; and

Whereas, The 128<sup>th</sup> Air Refueling Wing, affectionately known as "Milwaukee's Hometown Air Force," contributes to the city's economic vitality through an estimated \$84 million annual impact by fostering economic development and providing essential technical skills to the nation's airborne armed forces; now, therefore, be it
