This resolution authorizes the settlement of the lawsuit of *Dwight Pierce and Blue Cross of California v. City of Milwaukee*, in the amount of \$18,215.93.

Whereas, The plaintiff Dwight Pierce had commenced a lawsuit against the City of Milwaukee seeking \$50,000 in damages; and

Whereas, This matter was tried before a Milwaukee County jury on April 19 and 20, 2005; and

Whereas, The jury found the City to be 60% negligent, with plaintiff 40% negligent; and

Whereas; Sixty percent of the verdict amount totals \$16,440.00; and

Whereas, Plaintiff incurred statutory costs of \$1,775.93; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to pay this verdict; now, therefore, be it
